



PHOTOGRAPHY LICENSE AGREEMENT

THIS AGREEMENT (“**Agreement**”), effective as of February 2, 2022 (“**Effective Date**”) is made between Ed MacKerrow /dba “In Light of Nature Photography” (“**Licensor**”) and Skye Smith/Barker Realty (“**Licensee**”) (Licensor and Licensee shall be collectively referred to as the “**Parties**” and individually a “**Party**”).

Definitions.

1. Lower-resolution images optimized for viewing on web pages. They will be JPEG file format, with 1800 pixels on the long size, and JPEG compression quality at level 60 (for faster web page loading). They will be in the sRGB color space (with the Pro Photo RGB color space from my editing embedded).
2. Higher-resolution print quality images. They will be TIFF format full resolution (pixel dimensions vary by photo). They will be color corrected by me on a special computer display (soft-proofed) in the Adobe RGB color space (with embedded Pro Photo RGB color space). If the printer for your brochures can send me an ICC profile for the printer and paper they are using, I will soft-proof them for that, although a professional printer should be able to work fine with the versions purchased.
3. The images must retain a small and subtle credit in the lower right corner, "In Light of Nature". This credit will be embedded in the web and print copies purchased.

Product/End Use: Skye Smith/Barker Realty online and print articles, advertisements, and marketing of real estate. All uses must credit the photo, "In Light of Nature".

Territory: international

License.

Licensor hereby grants to Licensee the non-exclusive right to reproduce, display, broadcast, transmit and create a derivative work of (collectively "use") the Licensed Content in the Product/End Use, in the Territory, and during the Term as follows:

Use in online and print real estate marketing and advertising materials by broker Skye Smith and Barker Realty.

In addition, Licensed Content may be used for in-context promotion of the specified Product/End Use.

Licensed Content incorporated into a Product/End Use prior to the expiration of the Term may continue to be used in perpetuity solely in that Product/End Use.

All rights not explicitly granted in this Agreement are reserved to Licensor. Licensor is and will remain the sole and exclusive owner of the copyright and all other rights in and to the Licensed Content.

License Restrictions.

Except as necessary for the use of the Licensed Content in the Product/End Use, Licensee may not crop, rotate, alter, change or manipulate, or combine the Licensed Content with other image(s) or works without Licensor's prior written permission.

Licensee may not use any Licensed Content in a manner that is defamatory, pornographic or obscene, whether directly or in context or juxtaposition with specific subject matter.*

Licensee may not use the Licensed Content in any manner that would be offensive, including a use that involves or implies illegal activities, adverse medical conditions/procedures, other adverse health or mental health issues, substance abuse, welfare or economic aid, dating agencies, sexual preference, teen pregnancy, abortion and adoption, political or religious affiliation, smoking or alcohol usage, feminine hygiene, or incontinence or impotence.*

Licensee may not incorporate the Licensed Content in any logo, trademark or service mark.*

Licensee may not make the Licensed Content available in any medium in a manner intended to allow or invite a third party to download, extract or access the Licensed Content as a standalone file. For Licensed Content displayed on a website, Licensee shall post terms that prohibit the republication or transmission of the Image(s) as a standalone file.*



If the Licensed Content is used on a social media or other third party website or application that permits sharing of content, this Agreement shall be automatically revoked in the event the website seeks to exploit rights to the Licensed Content contrary to the terms of this Agreement, and Licensee shall take commercially reasonable efforts to remove the Licensed Content from such website.*

- Term.** From the Effective Date through indefinite. (“**Term**”).
- License Fee.** Licensee shall pay Licensor a license fee of \$135.00 per image (“**License Fee**”).
- Credit.** If the Licensed Content are used editorially, a credit shall be provided as follows: © Ed MacKerrow/In Light of Nature (the “**Credit**”). It is understood that Licensed Content used for advertising purposes do not require credit.
- Electronic Storage.** Licensee must retain the copyright symbol (©), Licensor’s name, the image identification number, all metadata and all other identification numbers associated with the Licensed Content that may be included as part of the electronic files delivered to Licensee. Licensee will take all reasonable steps to safeguard against unauthorized third party access to the Licensed Content.
- Payment Terms.** Licensee shall pay to Licensor the License Fee upon delivery to Licensee of the Licensed Content, regardless of whether Licensee actually uses any of the Licensed Content. Licensee may not cancel an order after delivery of a high-res digital file.
- If Licensee fails to pay the License Fee in full within 60 days, Licensor may add a service fee of 5% per month on any unpaid balance until payment in full is received.
- All rights to use the Licensed Content granted in this Agreement are subject to payment of the License Fee and any applicable service fees in full.
- Releases/Captions.** Unless otherwise stated, no model or property releases have been obtained. Licensor grants no rights and makes no warranties with regard to the use of names, people, trademarks, trade dress, registered, unregistered or copyrighted designs or works of art or architecture depicted in any Licensed Content. Licensee shall be solely responsible for determining whether a release is sufficient for the proposed use or is required in connection with any proposed use of such Licensed Content. Licensor used commercially reasonable efforts to identify the caption for each Licensed Image, but will not be held responsible for erroneous or incomplete caption information.
- Licensor Representations & Warranties.** Licensor represents and warrants to Licensee that: (a) except as otherwise provided in this Agreement, Licensor owns all right, title and interest in the Licensed Content as provided, including without limitation the necessary rights to grant Licensee the license granted above; (b) Licensor has full power and authority to enter into this Agreement; and (c) Licensor has not granted any licenses which would prevent it from granting the license granted above.
- LICENSOR MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, REGARDING THE LICENSED CONTENT, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. LICENSOR SHALL NOT BE LIABLE TO LICENSEE OR ANY OTHER PERSON OR ENTITY FOR ANY PUNITIVE, SPECIAL, INDIRECT, CONSEQUENTIAL OR INCIDENTAL DAMAGES, LOST PROFITS OR ANY OTHER DAMAGES, COSTS OR LOSSES ARISING OUT OF LICENSEE’S USE OF THE LICENSED CONTENT OR OTHERWISE, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, COSTS OR LOSSES.**



LICENSOR'S MAXIMUM LIABILITY ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR LICENSEE'S USE OF OR INABILITY TO USE THE LICENSED CONTENT (WHETHER IN CONTRACT, TORT OR OTHERWISE) SHALL, TO THE EXTENT PERMITTED BY LAW, BE LIMITED TO THE LICENSE FEE.

THE REPRESENTATIONS AND WARRANTIES MADE BY LICENSOR IN THIS AGREEMENT APPLY ONLY TO THE LICENSED CONTENT AS DELIVERED BY LICENSOR AND WILL BE INVALID IF THE LICENSED CONTENT IS/ARE USED BY LICENSEE IN ANY MANNER NOT SPECIFICALLY AUTHORIZED IN THIS AGREEMENT, OR IF LICENSEE IS OTHERWISE IN BREACH OF THIS AGREEMENT.

LICENSEE MAY HAVE ADDITIONAL RIGHTS UNDER SOME STATE LAWS.

Licensor Indemnity. Licensor agrees to indemnify, hold harmless and defend Licensee from all third party claims, liabilities, damages, costs and expenses, including reasonable outside attorney's fees, arising out of any alleged infringement or violation of any copyright with respect to the Licensed Content, so long as the Licensed Content is/are used in a way consistent with this Agreement.

Licensee Representations & Warranties. Licensee represents and warrants to Licensor that it: (a) has full power and authority to enter into this Agreement and to fulfill its obligations hereunder; and (b) shall not use the Licensed Content beyond the terms of this Agreement.

Licensee Indemnity. Licensee agrees to indemnify and hold Licensor harmless from any and all third party claims, liabilities, damages, costs and expenses, including reasonable outside attorney's fees, arising from the use of a Licensed Content other than as licensed pursuant to this Agreement, or as a result of any breach of this Agreement.

Entire Agreement. This Agreement contains the entire understanding and agreement of the Parties with respect to the subject matter contained herein, and supersedes all prior and contemporaneous oral and written understandings and agreements relating to the subject matter, except as expressly provided, and may not be altered, modified or waived in whole or in part, except in a writing signed by both Parties. In the event of any inconsistency between the terms contained in this Agreement and the terms of any purchase order or other writing sent by Licensee, the terms of this Agreement will control.

Binding Effect; Severability. This Agreement shall be binding upon the Parties and their successors and assigns. If any part of this Agreement is found invalid or unenforceable in any jurisdiction, that provision will not render invalid or unenforceable the other remaining provisions of this Agreement.

No Assignments. This Agreement is not assignable or transferable by Licensee. Any purported assignment in violation of this section is void.

Governing Law, Venue. The validity, construction, and performance of this Agreement shall be governed by the internal law of the State of New Mexico without regard to its choice of law rules. Any dispute arising under this Agreement shall be adjudicated exclusively in the state or federal courts located in the County of Santa Fe State of New Mexico. If Licensor is caused to present claims or suit as a result of any breach of the above terms set forth, Licensee shall be responsible for all reasonable legal fees or costs incurred.
